The Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) Regulations

To whom it may concern

The EU Regulation 1907/2006/EC "Registration, Evaluation, Authorisation and Restriction of Chemicals" (REACH) requires the European Chemicals Agency to evaluate all proposals of Member State Competent Authorities or ECHA for the identification of Substances of Very High Concern (SVHCs) in accordance with REACH, Annex XVII. Once agreed, these substances are included in the Candidate List of Substances of Very High Concern for Authorisation and thus considered for inclusion in REACH Annex XIV - the List of Substances Subject to Authorisation. We have reviewed our products with regard to the substances included in, and recently added to, the current Candidate List.

Based on our current knowledge of these products and the information (such as safety data sheets) provided to the company by its raw material suppliers, with the exception of the individual products listed below, our range of powder coatings do not contain any of the substances included in the Candidate List at levels greater than the tolerated maximum concentration values established by the EU Regulation 1907/2006/EC, or above 0.1%, whichever is the lower.
